AND WHEREAS, consequent to the course of search action under section 132 of the Income Tax Act, 1961, conducted on 18-12-2024, at various business and residential premises of Rajesh Sharma Group and other associated business entities and persons, hereinafter referred as "**Rajesh Sharma group**", during enquiry conducted so far, incriminating evidences of investments whose sources are undisclosed and unaccounted were found.

3. AND WHEREAS, various incriminating evidence of investments in the name of Smt. Radhika Sharma d/o Sh. Surjeet Singh in individual capacity and firms M/s Anant Multiventures (PAN: ACEFA0083F), and M/s Trident Multiventures (PAN: AARFT6785C) in which she is a partner and which are non-filers, have been unearthed. The sources of these investments are unknown and unaccounted. In the light of the above, it gets established that the Assessee, Smt. Radhika Sharma, is not filing her Income Tax Return (ITR) accurately and correctly.

Radhika Sharma, in her statement recorded u/s 132(4) of the Act, has expressed her unawareness about investments in multiple properties bought in her name to make such investment. She doesn't have any actual business or regular source of income, commensurate with the investments in her name. Hence the sources of these investments are unknown and unaccounted.

AND WHEREAS, during the search and seizure action and post search investigation, large scale income suppression, undisclosed investments and bogus expenses were found in the name of Smt Radhika Sharma, Sh Rajesh Sharma and their entities, which will likely lead to income escapement of more than Rs. 50 crores.

6. AND WHEREAS, to protect the interest of revenue and to safeguard recovery in search cases, I am satisfied that it is necessary to provisionally attach the properties (as per Table A) in the name of Smt. Radhika Sharma.

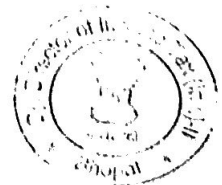
