Though we do not find any statutory mandate to provide reservations in appointments to the posts of Government pleaders and others, we would only suggest that there shall be an element of

inclusivity so that lawyers from all sections of the Society have an opportunity to come up in life.

In such view of the matter, we request the Office of the Advocate General to ensure that, during such appointments, due representation is given to lawyers from sections of the society and to women.

We make it clear that at least a few members from the Scheduled Tribe Community shall be accommodated in the future.

The Special Leave Petition stands disposed of in aforesaid terms.
